### FERPA (privacy act)

The Family Educational Rights and Privacy Act of 1974 (FERPA) is a federal law that governs the confidentiality of student records. Generally, the law requires that educational institutions maintain the confidentiality of what are termed education records, ensures that each student has access to his or her education records, and provides students with an opportunity to correct erroneous education records.

What this means to you as a student is that we are limited as to the information we can discuss with others regarding our student records, regardless of who may be paying your fees.

If you would like for others (possibly parents, guardians, coaches) to discuss any aspect of your housing records, you will need to sign the written consent form below to be added to your files in the Residence Hall Office.

Since the contract is with the student, we prefer to deal with you, the student. If you feel it would be better to speak with someone else concerning your account, we can do this, but only with your written release.
